

Case Study: Neuropathy

Terri's Story

Doctor's Story

Terri presented with neck pain, numbness and tingling, as well as motor function loss. She was having difficulty working due to not being able to feel what she needs to lift. Terri was unique due to her being a former world champion boxer, and the scar tissue that had built up.

With X-rays, we found 37.4 mm of forward head posture along with a 63% reduction of his cervical curve, and her lumbar spine had a 21% loss of lumbar curve. We went to work immediately with Terri to help her get well.

At the time this case study is being written, Terri has improved subjectively by noting that her upper extremity numbness and tingling have improved by 80%. She notes about the same improvement with gaining motor function in her arm. Objectively, Terri has improved her cervical curve by 21.5% in only 3 months.

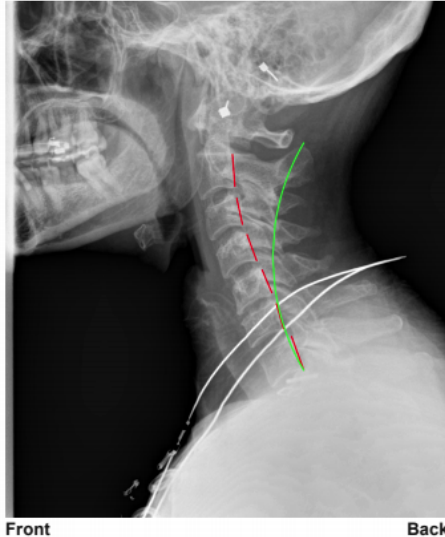

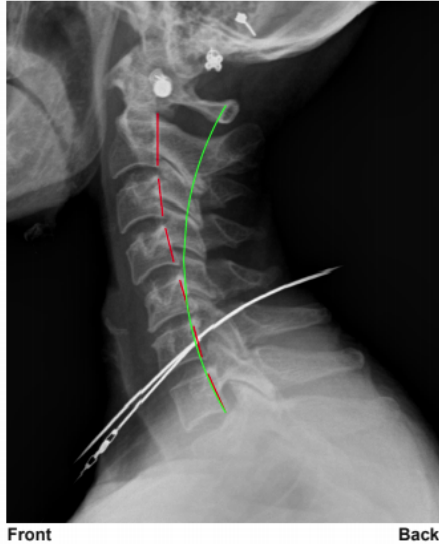
